Following approval by Clergy Session vote they are Commissioned (Provisional Member) or Ordained (Full Member) during the annual conference session. When a Full Clergy member withdraws to unite with another denomination under Para. 360.1 their certification of conference membership is returned. They remain Ordained but not a United Methodist clergy member. If a clergy withdraws from the ministerial office under Para. 360.2 both membership and ordination are surrendered.
